Once abated, the City will consider contracts with Habitat for Humanity and J.E.T to provide the manpower and training of employees to carry out the deconstruction under the administration of Habitat for Humanity. City currently has a Memorandum of Understanding with Goodwill Industries to identify and screen potential homeless individuals to work on the city demo process. City currently has one employee being trained in asbestos abatement and hopes to hire an additional person under the 2009 BEP.

<b>Plan for Employing Homeless Persons</b>	Saginaw's application contained a very progressive proposal and business plan for a Deconstruction Program. This program is designed to become a self sufficient system of addressing blighted properties within the City of Saginaw (and possibly other Cities of Promise) and will employ demolition, deconstruction, and economic development practices. The plan includes first partnering with Habitat, and eventually developing a site for a Deconstruction Facility that would include the following components: demolition; salvage; recycle and sales; millwork; and lot maintenance. At full operating capacity, this facility would employ up to 20 homeless persons and MPRI released prisoners. The project will hire staff in early January 2009 and begin implementing the plan at that time.
