OLD BUSINESS

Lakin distributed to the Board a printout of a correspondence he shared with Cindy Schnetzler from the Michigan Optometric Association. The correspondence addresses the concern of cosmetic lenses sales. Schnetzler indicated in the correspondence that there are three agencies that a person can report the illegal sale of these lenses to: Michigan Department of Labor & Economic Growth, Michigan Department of Community Health, and the Federal Food and Drug Administration.

Lakin stated that optometrists should be aware of the public campaign to make people aware of the risks that cosmetic lenses pose.

Patera suggested that the Department share this information with the Board of Medicine, Board of Osteopathic Medicine and Surgery, and the Board of Pharmacy, so that they can help with public awareness.

Ramsdell advised the Board that the Department can soon address the issue of cosmetic lenses and public awareness in the HealthLink publication.

NEW BUSINESS

Department Update

Lakin advised that he had been notified of a website containing an incorrect definition of Optometry. Ramsdell advised the Board that the Public Health Code does have the correct definition of Optometry, and it is the same as what is found on the LARA website. Patera suggested that the issue had been brought to the attention of the Department possibly because other websites may have an outdated definition posted. Schnetzler stated that she will send members of the Board the web link of the websites in concern.

Ramsdell introduced Norene Lind, Policy Manager and Kelly Hugh, Rules Analyst to the Board.

Ramsdell advised the Board that the Department is waiting for the budget change in October as the Department is currently working with two Department budgets currently.

PUBLIC COMMENT




