### **VETERINARY TECHNICIAN EXAM COMMITTEE**

Clark reported that members of the board may take the NAVLE exam during the November/December window at no cost to give their feedback regarding the exam.

Clark reported that at the last meeting there was discussion regarding the National Veterinary Technician exam. She stated there have been ongoing concerns regarding the cost of the exam.

Clark stated there are also concerns regarding the dates of the exam which will be held July 15 – August 15, 2010. Individuals will need to apply with for state licensure and then they may apply to the AASVB for the national exam.

Clark stated there are also concerns regarding the exam sites. She stated that the exam can be taken at any approved site in the U.S. and Canada. The exam will be a maximum of four (4) hours. She stated that the state exam will be held the third Friday in June at Michigan State University.

### **RULES COMMITTEE**

Vaupel reported that the committee members received a draft of the proposed rules changes for Continuing Professional Development. The next committee meeting is scheduled for March 5, 2010. The committee hopes to present the draft to the full board at the April 22<sup>nd</sup> meeting.

### **MOTION PREVAILED**

**Motion** by Letsche, seconded by Kopcha, to grant Petitioner a limited license for a period of two (2) years with the following terms and conditions:

- 1) Petitioner shall have direct, on-site supervision during the first year.
- 2) Petitioner shall have general supervision during the second year.
- 3) Petitioner shall submit quarterly supervisor reports during the first year of limitation.

Petitioner's license shall be automatically reclassified to a full and unlimited license.

Petitioner shall be placed on concurrent probation with the following terms and conditions:

- 1) Petitioner shall complete a minimum of twenty (20) hours of continuing education with five (5) of those hours being in exotic animals and two (2) of those hours being in medical records. The medical records course shall be completed within the first year of probation. The remaining thirteen (13) hours shall be in general small animal medicine. All courses shall be pre-approved by the board chairperson or designee.
- 2) Petitioner shall submit quarterly employer reports during the second year of probation.
