PUBLIC COMMENT

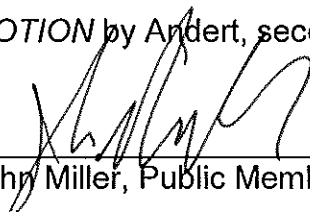
A public member commented that additional information pertaining to regulatory matters on the agenda should be available for the DSC's review and that the conferee should be prepared to discuss cases at the meeting.

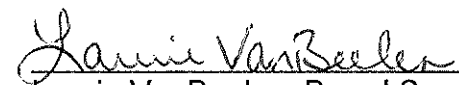
