Office of Regulatory Reinvention – Occupational Administrative Rules Committee Report to Governor

Ramsdell provided background information on the creation of the Office of Regulatory Reinvention (ORR), as well as the formation of the Occupational Licensing Advisory Rules Committee. She directed the Board members to the ORR Recommendation #D6 regarding the proposed deregulation of Occupational Therapists and provided rationale for the recommendation. She noted that any such action would require a statutory change.

Discussion was held amongst Board members and Department staff regarding the legislative process for making statutory changes and the impact the recommendation would have on the health profession. Ramsdell reminded Board members to refrain from seeking legislative changes on behalf of the Board. She suggested individuals contact professional associations and organizations to seek their assistance in voicing opposition to the proposed recommendation.

Hugh informed that the draft of the administrative rules and the regulatory impact statement have been submitted to ORR for review and approval before the rules can advance to the public hearing stage.

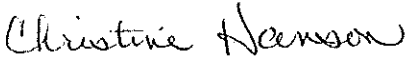

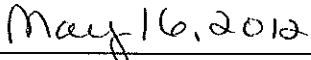
