The End-of-Program (EOP) 2014 Early Childhood Collection opened in early March. Certification may begin on May 5, 2014. Data for children who received early childhood program services from February 13, 2014 through August 15, 2014 (the reporting period) should be included in this collection window. The collection must be certified on or before 11:59 p.m. EDT on August 20, 2014.

Be sure to include exit data for children who left a program during the reporting period. Children who meet the age eligibility requirements to enroll in GSRP for a second year must reapply, and their applications must be considered alongside all other applications when enrollment decisions are made for next year. Therefore, **all GSRP children reported in the EOP Early Childhood Collection should be reported with program end dates and exit reasons.** Children who are reenrolled for another year of GSRP services should be reported with new program start dates in the Fall Early Childhood Collection. Children who are not continuing in the same program next year should be reported with the applicable program end dates and exit reasons in this collection window.

CEPI will be completing a data quality analysis of all certified and error-free staging records submitted in this collection through 11:59 p.m. EDT, August 5, 2014. If your entity plans to certify data in this collection and would like to take advantage of this service, please either certify your EOP 2014 Early Childhood Collection or ensure your submitted records are error-free by 11:59 p.m. EDT, August 5, 2014. Emails regarding possible anomalies will be sent to MSDS authorized users no later than August 13, 2014. This will allow users time to review potential issues and make any necessary adjustments prior to the August 20 certification deadline.
