Department Update

Lind referred to the handout and discussed the Occupational Licensing Advisory Rules Committee (ORR) report regarding the recommendation to deregulate Licensees for 18 Occupations and 9 Boards. The (ORR) recommended medicine, osteopathic medicine, and podiatric medicine should be combined while maintaining separate licenses. These are only recommendations at this time pending introduction of legislation that would need to be passed through the Legislature and signed by the Governor in order for it to become enacted.

Kreitman noted that he is a member of the Controlled Substance Advisory Commission (CSAC). The CSAC is drafting a report, and he intends to make recommendations regarding Podiatry for inclusion in the draft.

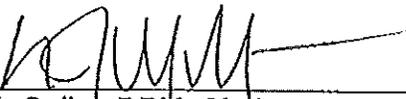

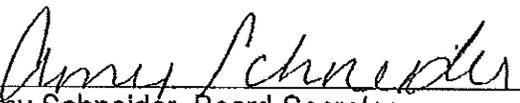
