Sir

The sale by the Indians of their lands in the vicinity of, Chicago, and the rapid extension of settlements up the peninsula of Michigan, are the cause of some movements now in train among the Lake Bands, which will probably be more fully developed in a few years. Some of the Ojibwas, consisting of those who do not elect to go west, will distribute themselves northwards, which is retreating on the track of their migration. The Ottawas who will also retrograde on their track, are making incipient arrangements to go to the islands of the Lake Huron, borders of Upper Canada to which some of them have already proceeded, and where improvements appear to be held out by the authorities of the British Indian Department, for their settlements.

The enclosed minutes of a conference with deputies sent from Ottawa Island are connected with these movements. They are forwarded, in compliance with the Indians former request.
