MSDS Fall 2016 General and Early Childhood Collections Certification Deadline

The Fall 2016 [General](#) and [Early Childhood](#) Collections will close at 11:59 p.m. EST, tonight (Wednesday, November 16). The certification status for your district's collections must be "Written to Queue – Available for Certification," "Processing Certification" or "Certified" by this deadline. Please remember that your staging area must be error-free and you must successfully complete the Quality Review process before the system will allow you to certify.

REP Submission Deadline Reminder

The Fall 2016 Registry of Educational Personnel (REP) deadline is 11:59 p.m. EST, December 1. Be sure to check your Personnel Submitted reports in REP to ensure that all of your records have been updated and that all of your new employees have been properly reported. When all current employee records have green check marks and all new staff member records have been submitted and have green check marks, the submission is complete.
