Komal Manubhai Acharya, P.T. – Consent Order and Stipulation

MOTION by Middha, seconded by Simmons, to reject the Consent Order and Stipulation and offer a counter-offer to suspend Respondent's license for a minimum of one (1) day until she enters into a Health Professional Recovery Program (HPRP) monitoring agreement in the matter of Janet M. Wisniewski, P.T.

Respondent shall enter into a HPRP monitoring agreement within six (6) months. If she fails to enter into the contract within six (6) months, Respondent must apply for reinstatement. Upon receipt of the HPRP monitoring agreement, Respondent shall be placed on probation for one (1) year as currently agreed upon in the proposed Consent Order and Stipulation.

Additionally, a fine shall be assessed in the amount of \$1,000.00, payable within 60 days from the date of the Order.

The Disciplinary Subcommittee finds that there are violations of all Counts, as alleged in the Complaint and does not dismiss 16221(b)(ii) and 16221(b)(iii).
