The Spring 2016 Early Childhood Collection will close at 11:59 p.m. EST tonight (Wednesday, February 17). The Certification Status for your district's collection must be "Written to Queue – Available for Certification," "Processing Certification," or "Certified" by this deadline. Remember, your files must be error-free, and you must successfully complete the Quality Review process before the system will allow you to certify.
