- The color scheme will change to be consistent with SoM websites.

High School Equivalency Data Findings in MSDS and GAD

The [Graduation and Dropout application](#) is open from Monday, Oct. 4 through Thursday, Dec. 2 for ISD auditors to conduct the annual audit of active cohorts (2019 through 2024). District authorized users may also preview auditable graduation and dropout rates.

Beginning this year, auditable rates will now include High School Equivalency proficiency data from the state workforce agency. For applicable students, a state GAD audit finding has been created and the cohort status has been updated to GED Completer. These updates are also reflected in GAD and MSDS reports.

District authorized users may also preview auditable graduation and dropout rates.

Beginning this year, auditable rates will now include High School Equivalency proficiency data from the state workforce agency. For applicable students, a state GAD audit finding has been created and the cohort status has been updated to GED Completer. These updates are also reflected in GAD and MSDS reports.
