OLD BUSINESS

Administrative Rules

Carpenter stated that the Human Trafficking Continuing Education rules are moving forward through the process. Evers suggested that they have another conference call before April to review. Evers also wanted to make sure that the Human Trafficking CE are part of the FAQ's.

School Athletic Trainers

Carpenter discussed the issue regarding the hiring of non-licensed Athletic Trainers at schools and what happens to the school. She did not find anything in the statute that states that schools have to hire licensed Athletic Trainers or that they are required to review whether the Athletic Trainer has credentials or not. If there is an Athletic Trainer at the school who is not licensed, they can be reported to the local prosecuting attorney's office. Evers spoke about concern from Athletic Trainers when they are covering an event and give advice regarding an injured player and the coach does not comply with that advice. She advised that Athletic Trainers can have the school sign provisions that include exempting the Athletic Trainer's responsibility if the coaches do not take the advice of the Athletic Trainer covering the event.

NEW BUSINESS

Department Update

Carpenter updated the Board regarding BPL staff changes within the Boards and Committees section.

HPRC Nomination – Paul Schmidt

MOTION PREVAILED

Reporting of Non-Licensed Individuals

Eyers opened the discussion with the question of whether Athletic Trainers need to be licensed or not in Michigan. Carpenter explained that Athletic Trainers are a protected profession under Michigan law and the statute provides that an individual using the title of an Athletic Trainer has to be licensed in Michigan. Tinkley questioned whether the school is informed if their Athletic Trainer is served with a Cease and Desist order. Carpenter replied that the school probably would not be notified. Vance questioned if it was part of schools' credentialing process. Eyers requested that Karen check with the education department regarding the credential process as it pertains to Athletic Trainers.


