Rifle River Area Deer Season 1965

This year there was a 6 per cent increase in the legal buck kill over that of 1964. A total of 35 legal bucks were taken during the gun season; 74 per cent of these bucks were  $1\frac{1}{2}$  years old. Hunters holding antlerless permits took a total of 36 adult does, 17 doe fawns, and 13 buck fawns. This was a decrease from the previous year of 3 adult does, 1 doe fawn, and 7 buck fawns. The overall kill came to 101 deer, not including the unclaimed deer. This was roughly 13 per cent less than the total kill last year. The total hunting permits issued increased by 102; the total hours of hunting was slightly down. There were 38 per cent fewer deer reported seen this year by hunters. Hunters using the area came from 39 counties, 3 other states, and the Province of Ontario, Canada. The buck kill by age groups is as follows:

The oldest buck taken was  $3\frac{1}{2}$  years old. The heaviest buck was a  $2\frac{1}{2}$ -year-old, 4-point, which weighed 143 pounds. The average weight of bucks increased by 1 pound this year. The average weight of fawns and adult does also increased slightly.

The weather was in general mild. There was a 2-inch snowfall opening morning which started about 4:30 a.m. and lasted until 8 a.m. The temperature was warm, and the following day there was no snow. We received .72 inches of rainfall on November 26, and another 1.24 inches of rain on the 27th, which tended to make the swamps impassable to hunters. There was considerable flooding of roads and lowlands over the entire area. On November 28, we had 1.2 inches of snowfall, which helped the hunters. On December 3 we received snow flurries which resulted in an inch or two of snow remaining on the ground from then on through the rest of the season. During the entire season, the lowest temperature reached was 18 degrees, and the highest temperature was 50 degrees on November 27.

On the first day of the season, a total of 666 permits were issued. It is possible that in the busy periods some hunters came in and out without reporting at the checking station. Over two-thirds of these permits were issued before 8 o'clock in the morning. This required the services of five Department personnel working steady from 5 o'clock in the morning.



In general, there was considerable discontent amongst the hunters because they were not seeing deer in large numbers. Several hunters, with whom I was in contact, hunted as much as five to six hours a day for an entire week without seeing a deer, although most of them reported seeing tracks. These were hunters who in the past have taken home deer from the Rifle River Area. There is no doubt that deer are down somewhat on the area. I don't believe that we have reached a danger point. There are considerable signs of the browse starting to get ahead of the deer, which is good. The deer were up slightly in weight this year. I would like to call attention to the fact that last year's kill was the third largest kill on record, and we cannot hope to make a record each year.

The prime need on this area at the present time is for immediate action in getting a commercial cutting program started. The longer we delay getting this cutting program initiated, the more deterioration we will have in aspen, which will result in poor quality timber products. If a cutting program is started, I can see no reason why we cannot continue harvesting deer at about the same rate they were harvested this year.

One last comment is perhaps in order in regard to the operation of the Rifle River checking station. The method of handling the campers in regard to checking in and checking out, especially the issuing of permits to campers to hunt, was not satisfactory during this hunting season. It is very evident that we will lose control of getting an accurate check on information if we continue to give the campers the freedom of entering and leaving the area that they have been given this year and last year. Each person entering the area during the hunting season should be issued a permit regardless of what his purpose is on the area, and he should return his permit before leaving the area even if he is going to return the same day.

In regard to the regulations written on the permit, certain changes should be instituted in order to provide the checking station with better control of the large number of people using the area during the hunting season. At one time the permit included a statement that no person should leave the area without surrendering his permit, and that it was illegal to leave the area by any means, such as walking or by boat, without first surrendering the permit at the checking station. We had several difficulties this season with hunters, especially the campers, leaving the area with their permits (this is permitted under the present regulations), and then driving the main roads to another part of the area and entering it by crossing the wire. They actually complied with everything the regulations required. They had permits; they were allowed to leave the area with the permits, and nowhere on the permit did it say that they could not re-enter the area by crossing the boundary.

If we are to continue getting useful information, I would recommend that we revise our hunting regulations on the area in order to permit better hunter control.
