CHAIRPERSON'S REPORT

Spencer reported that he attended a conference on Increasing Access to Oral Health Care in Michigan held August 22, 2011. Also in attendance at the conference were Board members Franklin, Hennessy and Stamm. He stated that the topic of discussion were three possible solutions to the increasing access to care; the introduction of a mid-level provider, increasing utilization of existing modes of practice and collaboration linking oral health care providers with other care providers.

Spencer reported that he attended the American Association of Dental Board's (AADB) annual meeting held October 9-10, 2011. He stated that the leadership of the AADB unveiled a new program in the area of disciplinary actions. Spencer provided a brief synopsis of the

Assessment Services Program (ASP). Spencer informed on litigation between North Carolina Board of Dentistry and the Federal Trade Commission which is currently being appealed in Federal Court of Appeals.

PA 161 Update

Chris Farrell, Director for the Department's Oral Health Program reported three agency renewals: Washtenaw Children's Dental Clinic, Washtenaw County Head Start and Health Delivery, Inc. Two changes to existing programs: Winning Smiles and Care Free Dental-Lansing. She announced that the Oral Health Program's Annual Report should be available in December.


