**MSDS EOY General and SRM Collections Closing June 30**

The MSDS [EOY 2016 General Collection](#) will close at 11:59 p.m. EDT on Thursday, June 30, 2016. The certification status for your district's collection must be "Written to Queue – Available for Certification," "Processing Certification" or "Certified" by this deadline. Your staging area must be error-free and you must successfully complete the Quality Review process before the system will allow you to certify.

This is your district's final opportunity to report student enrollments and exits, make adjustments to student demographic data, and report student attendance for the 2015-16 school year. Please pay special attention to program eligibility or participation data, including LEP exits, special education discipline, initial IEPs, McKinney-Vento, 31a eligibility, and supplemental nutrition eligibility.

The [2015-16 SRM Collection](#) also closes on June 30 and will reopen on July 20 for the submission of Section 23a claims, LEP exits, and exit status changes for the Graduation Rate Appeals Window.

**SID Final Reminder**

The SID submission deadline is June 30, 2016. Our thanks to districts that have already completed their submissions. As a reminder to all district authorized users (especially bulk uploaders), be sure to check your "Submission Results" reports within the SID Application to ensure that all of your schools/facilities have been updated and properly reported.

We appreciate your attention to this matter and your cooperation to ensure complete and accurate reporting.

**EEM New Features Beginning July 5**

On July 5, 2016, the following features will be available in the EEM:

The EEM detailed search function will have a new look and include features that will make searching easier.

- Search values are displayed directly on the search screen.
- Users will no longer need to select a drop-down menu to find characteristic values they are seeking.
- Search results can be reviewed after additional search modifications are made.

Early/Middle Colleges: The Early/Middle College field will identify the entity as an Early/Middle College or an Early/Middle College program.

Summary Field Roll Ups: ISD, LEA and PSA district entities will display a summary of grades (authorized and actual), educational settings (authorized and actual), and early childhood program participation for schools and unique education providers to which they are the parent district. LEA and PSA district summary fields will no longer roll up to the ISD district.

**D/CH Submission Deadline July 15**

The deadline to submit the Days and Clock Hours of Instruction Report (DS-4168) is July 15, 2016 for all district users. Please submit your report as soon as possible to allow for the correction of any errors discovered during the intermediate school district (ISD) review. ISD users have until August 1, 2016 to review and certify the report.
