These continuing education courses shall be Board-approved and shall not apply toward licensure renewal.
- 2) Respondent shall comply with all applicable provisions of the Public Health Code.
- 3) Respondent shall be solely responsible for payment of all costs incurred in complying with the terms of this order.
- 4) Respondent shall be fined in the amount of \$2,500.00, payable within 90 days.
