### MSDS Direct Certification Report Refresh: September 26

The report of students who are directly certified to receive free supplemental nutrition services was refreshed Monday, September 26, using the following records:

- EOY 2016 General Collection certified records.
- SRM 2016-17 records that were certified prior to September 21.
- Early Roster Collection records that were resolved and error-free prior to September 21.

The next refresh is Friday, October 7 using records submitted prior to October 5.

### Fall Count Day and SRM As Of Date

Today, October 5, is the State-legislated Fall 2016 pupil membership count date. Accordingly, districts can no longer submit a student record with an "As Of Date" prior to 10/5/2016 in the SRM Collection. Any updates to student records that were effective prior to this date should be included in the Fall 2016 General Collection.

- Student Pathways Secondary CTE Programs. 2010-11 through 2014-15 secondary career and technical education (CTE) data have been added to the Student Pathways report. This report proves secondary CTE program enrollment history only for the students who have enrolled in a college or university as of the 2009-10 school year.
