NCEES Zone Meeting Update

Junior discussed CBT applications and the deregulations in Indiana cease and desist orders. Fobes also discussed continuing education related to this.

Suggested Sanctions Subcommittee Report

Hookham is working with Gilbert Barish of the Michigan Board of Architects, to review and compare sanctions. Hookham will have an update at the September meeting.

CE Audit Report

Wright stated that the Department will be conducting a CE audit of the renewed licensees that are randomly selected. She also explained to the Board the process if a licensee's compliance comes into question and the steps involved for the licensee to remedy the deficiency. Wright will provide a CE audit status update for the next meeting.

Licensing Requirements

Carpenter stated that the use of Administrative Rule 22 should be used within reason. Hookham was concerned over what type of experience should be permissible in licensing requirements and how that experience should be interpreted. Wright explained that beyond experience, the applicant also has to submit 2 references from licensed professionals regarding the licensee's experience. Carpenter explained that the experience requirement can be addressed through rule revisions.

Junior spoke about the Engineering Society of Detroit's (ESD) Engineering SMaRT Michigan program. This program is designed to provide experiences for high school students and engage them in STEM related activities and opportunities.
