- March 4 – Cutoff date for Early Roster (nonpublic schools only) and SRM records to be included in the matching for March 7 Direct Certification Report refresh
- March 5 – Early Childhood End of Program 2014 Collection opens
- March 5 – Spring 2013 General Collection data quality snapshot
- March 7 – Direct Certification Report refreshed
- March 19 – Spring 2014 General Collection submission deadline
- March 19 – Fall 2013 FTE Audit window deadline (24 weeks after Fall count day)
- March 20 – Department Accountability Services (DAS) "As of Date" for Spring assessments
- March 26 – Spring 2014 General Collection certification window closes at 11:59 p.m. EST
- March 27 – 31 (Tentative) MSDS offline for system maintenance
- April 1 – Spring 2014 DS4061 available for editing by ISD/State auditors
- April 1 – Cutoff date for Early Roster (nonpublic schools only) and SRM records to be included in the matching for April 4 Direct Certification Report refresh
- April 4 – Direct Certification Report refreshed
- April 30 – SRM window for submitting Spring 2014 assessment updates closes at 5 p.m. EST ("As of Date" must be between 2/12/2014 and 3/20/2014 to be used by DAS for assessment and accountability reporting)
- May 1 – (Tentative) MSDS End of Year General Collection opens
- May 1 – (Tentative) 2014 Early Roster Window opens
- May 1 – (Tentative) 2013-2014 School Year TSDL Window opens
- May 1 – Last Student Data Pull from MSDS to BAA for Spring 2014 Assessments
- May 1 – Cutoff date for Early Roster (nonpublic schools only) and SRM records to be included in the matching for May 6 Direct Certification Report refresh
- May 6 – Direct Certification Report refreshed
