## ***PRESENTATION***

Lind introduced Joan Hartman from the U.S. Department of Justice, Eastern Michigan Region. Ms. Hartman gave an informative presentation on how USAMIE is using data to find health care fraud and abuse in the East Michigan Region. Hartman stated that home health care is the largest problem area in addition to collusive arrangements between physicians and independent pharmacies. Hartman believes that over 200 physicians are currently involved in fraudulent activities. Three hundred (300) prosecutions have been handled in the last three (3) years. She would like to find avenues for cooperation between DOJ and the Task Force on Physician's Assistants in dealing with this problem.

Discussion was held about possible ways to share information between the U.S. Department of Justice and the Department/Board. Any arrangement would have to abide by current LARA policies and procedures for filing complaints. Hartman was encouraged to contact Director Carole Engle to discuss further how information might be shared.

Carpenter informed that a Public Hearing was held on November 22, 2013 for the proposed administrative rules, and no one attended. Hence, the rules were finalized and became effective on March 20, 2014.

Carpenter distributed and summarized two Memorandums entitled "Summary of Public Acts 95-98 of 2014" and "Changes to Board of Pharmacy Rules Affecting Prescribers."


