Respondent's license shall be automatically reinstated if, within six (6) months, the Department receives satisfactory written evidence from the Health Professional Recovery Program (HPRP) verifying that the Respondent has undergone a substance abuse/chemical dependency evaluation; has entered into a disciplinary monitoring agreement with HPRP; and that HPRP has endorsed Respondent as safe to practice; OR that HPRP has determined that Respondent does not require treatment monitoring. If Respondent's license remains suspended for more than six (6) months, Respondent must petition for reinstatement.

Additionally, a fine shall be assessed in the amount of \$1,000.00 payable prior to reinstatement.

Upon automatic reinstatement, Respondent shall be placed on probation for one (1) year with the following terms and conditions:

- (1) Comply fully with the HPRP monitoring agreement.
- (2) Submit quarterly employer reports.
- (3) Comply with the public health code.

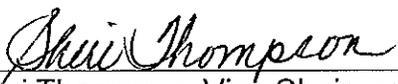

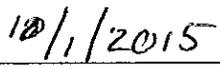
