- **Retained In Grade**. 2015-16 school year data are available in preview. The Retained In Grade report displays counts and percentages of students enrolled in the same grade level for two consecutive school years.
- **Non-Resident Status**. 2015-16 school year data are available in preview. The Non-Resident Status report reflects students who live in your district but attend school in a different district, and students who reside in other districts but attend school in your district.
