Respondent is placed on concurrent probation for a minimum of (1) one year and must submit quarterly reports from her supervisor. If Respondent's license remains suspended for a period longer than six (6) months, Respondent must petition for reinstatement in the matter of Rose Satterwhite, MFT, LMSW.

Respondent must submit proof of successful completion of a minimum of eight (8) hours of Board-approved CE credits in the area of ethics. If Respondent's license remains suspended for a period longer than six (6) months, Respondent must petition for reinstatement in the matter of Joseph Gerad Waudron, LMSW.
