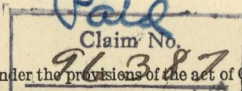
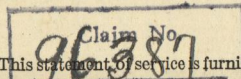

1. This statement of service is furnished under the provisions of the act of Congress approved July 11, 1919.
2. This statement is furnished primarily for historical and statistical purposes, although it may be used in adjudicating claims in which the State is solely concerned. It is not to be used before a court of justice or in support of any claim against the Federal Government. The law prohibits the disclosing of any information that may be used in the prosecution of a claim against the Government, except to the proper Government officials.
3. Applications from individuals, other than historians and statisticians, for information from this statement of service should be denied and the applicant directed to apply for the information to the Adjutant General of the Army, who is the custodian of the official records of the Armies of the United States. Exceptions to this rule may be made in the case of officials of patriotic and philanthropic societies and associations when it is known positively that the information is to be used exclusively by said society or association, and will not be made public nor communicated to any individual who may use it directly or indirectly as a basis for, or in the prosecution of, a claim against the Government, or to the injury of the soldier.
4. Except as hereinbefore provided, all persons seeking information relative to the military and medical histories of the soldier should be denied information from, or access to, the records of the War Department, and no effort has been made to compare the entries recorded herein with the entries recorded in the files of the War Department.
5. Except the data contained on the first four lines of this statement is prepared as far as practicable from the service record of the soldier, and no effort has been made to compare the entries recorded herein with the entries recorded in the files of the War Department.
6. Some enlistment papers show age at enlistment in the same form as those on the enlistment paper.
