Notice

Notice is hereby given, that the reservations to the U.S.I.D. in this vicinity having been recently surveyed, the intercourse laws will cease to operate upon them, over all other portions of the country, they will be rigidly enforced. Licenses to trade will be granted at this office, under the usual regulations for all the country north of White river and Thunder Bay river of the Peninsula of Michigan. Permits to cut wood and saw logs will only be granted hereafter, on the payment of a fixed money compensation to the Indians, which will be stated at the office. All existing permits for these objects, are hereby revoked.

Hunting and trapping by white men is strictly prohibited by law, as well as the residence of Boatmen or Clerks in the Indian Country, after the expiration of their licenses. Provisions are inserted in the laws forbidding the formation of settlements on Indian lands, or any occupancy which is designed to originate a claim to title. Instructions have recently been received, declaring that no permission will hereafter be given for building Saw Mills on Indian Lands. All person having occasion to transact business with the Indians on their own lands are strictly prohibited from using and introducing ardent spirits & wine. Other points will be stated on application. The regulations are designed to protect the Indian in the rightful occupation of his lands, and it is expected by the Dept. of War that a cheerful compliance will be yielded to them. For all infractions, information will be filed with the U.S. I. D. Attorney for the territory, who is directed to be the medium of prosecution..

D. in this vicinity having been recently amended, the interior laws will cease to operate upon them, over all other portions of the country, they will be rigidly enforced. Licenses to trade will be granted at this office, under the usual regulations for all the country north of White river & Thunder Bay river of the Peninsula of Michigan. Permits to cut wood and saw logs will only be granted hereafter on the payment of a fixed money compensation to the Indians, which will be stated at the office. All existing permits for these objects, are hereby revoked.

Hunting and trapping by white men is strictly prohibited by law, as well as the residence of Boatmen or Clerks in the Indian country, after the expiration of their licenses. All persons having occasion to transact business with the Indians on their own lands are strictly prohibited from using or introducing or distilling spirits & wine. Other points will be stated on application. The regulations are designed to protect the Indians in the rightful occupation of his lands, and it is expected by the Dept of War that a cheerful compliance will be yielded to them. For all infractions, information will be filed with the U. S. Attorney for the territory, who is directed to be the medium of prosecution.
