- October 7 – SE-4094 submission to State of Michigan deadline (closes at 11:59 p.m. EDT)
- November 5 – Fall 2014 General Collection submission deadline
- November 12 – Early Childhood Fall 2014 Collection certification deadline (closes at 11:59 p.m. EDT)
- November 12 – Fall 2014 General Collection certification deadline (closes at 11:59 p.m. EDT)
- November 17 – 2013-2014 Audit Narrative deadline
- November 17 – 2013-2014 FID submission deadline (closes at 11:59 p.m. EDT) *(Note: Although the FID application will remain open until 11:59 PM on 11/17, MDE may choose to enact a state aid penalty for those districts who do not have their submission completed by the legislated deadline of 11/15/2014.)*
- December 1 – Fall 2014 REP Submission closes at 11:59 p.m.
