ent is furnished primarily for historical and statistical purposes, although it may be used in a judicial proceeding in the State is solely concerned. It is not to be used before a court of justice or in support of any claim against the Government. The law prohibits the furnishing of any information that may be used in the prosecution of a criminal case, except to the proper Government officials.

ons from individuals, other than historians and statisticians, for information from this statement of service and the applicant directed to apply for the information to The Adjutant General of the Army, who has official records of the Armies of the United States.
