New Board members were welcomed. Letsche asked everyone to introduce themselves and provide a brief background of their professional experience.

COMMITTEE REPORTS

Rules Committee

Letsche explained to new Board members the function of the Rules Committee. He also updated them on the Office of Regulatory Reinvention's decision not to allow the Board to promulgate continuing education rules until the Veterinary Medicine statute is amended to expressly allow/require it. He noted that Michigan is the only state that does not have continuing education requirements for Veterinarians.

Veterinary Technician Exam Committee

Rohwer reported that the Committee has requested to view the practice exam for new Veterinary Technician National Examination (VTNE) that is being prepared for the summer 2013 window.

Clark stated that she communicated last week with Nancy Grittmann, Program Manager for the Veterinary Technician National Examination (VTNE) from the American Association of Veterinary State Boards (AAVSB). The practice test is not available for Board review yet, as it has not yet been completed. Clark is working with the AAVSB to allow the committee to review the practice exam, which will be the same format as the final exam.

AAVSB Practice Act Model – Comments

Letsche explained the functions and purpose of the American Association of Veterinary State Board.

Lind reported that many national associations representing a variety of health boards produce model practice acts. They routinely ask our board members to provide feedback. The Board was asked to provide any feedback to Lind by the March 31, 2013 deadline. She would, in turn, share it with the AAVSB.

AAVSB Nomination Form

The AAVSB Nomination Form was shared with Board members. Letsche recommended that anyone interested in becoming involved as a board member at the National level should attend a conference first. All Board members are welcome to attend conferences; however, AAVSB typically only covers the travel expenses of one or two people. The annual conference will be held in Kansas City, Missouri, September 19-21, 2013.

Department Update

Lind reported that all of the Board Chairs had a meeting with the new Bureau Director in January regarding the need to increase license fees, since many health professional license fees have not been increased since 2002. Lind shared the current fee structure for all Boards.

Lind reported that there more than 6,500 Veterinarians and Veterinarian Technicians currently licensed in the State of Michigan.

Lind distributed "Standards of Conduct" forms to the new Board members to review and keep in their Board files.
