Department Update

Siracuse addressed a question brought to him by Board Member Sevensma between board meetings. Board member Sevensma recognized that American Osteopathic Association (AOA) programs were in a transition period at the same time that new rules were being promulgated, and she voiced her concerns that applicants may be prohibited from licensure as such programs, which are required for licensure applicants, transitioned into a single Accreditation Council for Graduate Medical Education (ACGME) system. Siracuse addressed this concern by stating that it would not matter when the new rules were completed; both rule-sets will recognize ACGME programs for licensure purposes. This is true under the old rule, R 338.106(2), which is currently applicable. It will also be true under the new rule, which will be R 338.121(2) & (4) when fully promulgated.

Lind updated the board regarding the bureau reorganization.

Walters requested Lind's presence at the upcoming August 6, 2015 meeting.
