Respondent's license shall be automatically reinstated if, within six (6) months, the Department receives satisfactory written evidence from the Health Professional Recovery Program (HPRP) verifying that the Respondent has undergone a substance abuse/chemical dependency evaluation, has entered into a disciplinary, non-confidential monitoring agreement with HPRP, and that HPRP has endorsed Respondent as safe to practice, OR that HPRP has determined that Respondent does not require treatment monitoring. If Respondent's license remains suspended for more than six (6) months, Respondent shall petition for reinstatement.

Additionally, a fine shall be assessed in the amount of \$2,500.00, payable prior to reinstatement.

Upon automatic reinstatement, Respondent shall be placed on probation to run concurrent with the period of Respondent's HPRP monitoring agreement, if treatment monitoring is required, with the following terms and conditions:

- (1) Respondent shall comply fully with her HPRP monitoring agreement.




