If the Respondent has been found to not be in compliance with the Final Order for Complaint No. 322510, then Respondent's license shall be suspended. The motion carried by unanimous vote.

Wendy Foster, representing Dorsey School of Beauty, addressed the Board.


NEXT MEETING DATE
