Respondent's license shall be automatically reinstated when the Department receives satisfactory evidence from the HPRP verifying either that (1) Respondent has entered into a disciplinary confidential monitoring agreement with the HPRP and that the HPRP has endorsed Respondent as safe to practice, or that (2) the HPRP has determined that Respondent does not require treatment monitoring.

Upon automatic reinstatement, Respondent shall be placed on probation for one (1) year with the following terms and conditions:

(1) Respondent shall be required to complete a minimum of three (3) credits of continuing education in the following area:

a. Ethics

Respondent shall comply with the HPRP, as necessary.

Additionally, a fine shall be assessed in the amount of \$250.00, payable prior to application for reinstatement or relicensure.
