2. This statement is furnished primarily for historical claims in which the date is solely concerned. It is not to be used by the Federal Government. The law prohibits the furnishing of such information against the Government, except to the proper Government authorities.

3. Applications from individuals, other than historical claims, should be denied and the applicant directed to apply to the proper authorities for the official records of the Armies of the United States. Applications from patriotic and philanthropic societies and associations should be denied, and will not be made indirectly as a basis for, or in the prosecution of, a claim.

4. Except as hereinbefore provided, all persons's service records should be denied information from, or access to, which would be made available to persons who might perpetrate fraud.

5. Except the data contained on the first four lines of the service record is prepared as far as practicable from the service record with other records, except where a discrepancy exists.
