**MSDS: Direct Certification Report Refresh on July 29**

The [Direct Certification Report](#) for the 2016-17 school year has been released in the MSDS. All student records in the End-of-Year 2016 General and Early Roster collections that were resolved and error-free prior to July 26 were included in the source file for this release.

**MSDS and EEM Migrated to MILogin**

MSDS and EEM have migrated from Single Sign-On to MILogin. [MILogin](#) is the new State of Michigan Identity, Credential, and Access Management (MICAM) solution.

We have updated [CEPI Application Security Forms](#) to reflect the migration.

**MSDS: EC EOP 2016 Certification Deadline**

The [Early Childhood EOP 2016 Collection](#) will close at 11:59 p.m. EDT, Wednesday, August 17, 2016. The Certification Status for your collection must be "Written to Queue – Available for Certification," "Processing Certification" or "Certified" by this deadline. Your collection must be error-free and you must successfully complete the Quality Review process before the system will allow you to certify.

We encourage you to report all early childhood children who received services at any time between February 11 and August 10, 2016, but you are only required to report children participating in the Great Start Readiness Program and the Early Childhood Block Grant Program.

Be sure to include exit data for children who left a program during this reporting period. All GSRP children reported during the year *must* be reported with program end dates and exit reasons by this EOP Early Childhood Collection. Children who meet the age eligibility requirements who are enrolled for another year of GSRP services would be reported in the Fall Early Childhood Collection with new program start dates.

Children who are not continuing in the same program next year should be reported with the applicable program end dates and exit reasons in this collection.

**MSDS: Graduation Rate Appeals Window Open**

The Graduation Rate Appeals Window is open in MSDS through Wednesday, September 14, 2016. Appealable graduation and dropout rates will be available in the GAD Application in mid-August. You should not wait for the appealable rates to review your graduation and dropout data in MSDS.
