## Message from the Director

*Phil Stoddard talks about the importance of employer-sponsored retirement plans.*

In the world of retirement, there are the *haves* and the *have-nots* - workers who have an employer-sponsored retirement plan and those who don't. In fact, there are more American workers today without an employer-sponsored plan than those who do have one.

At ORS, most of us spend our time dealing with the *haves*. But you should know we're also rooting for the *have-nots*. The past several years we've seen a growing trend in our country, where employers are reducing or ceasing retirement plan offerings.

We set an example by offering sound retirement plans that not only benefit workers, but employers and communities too. We also try to spread the word that providing good benefits improves the current and future wellbeing of our citizens; help employers attract, retain, and reward good employees; and support and strengthen economies.

Increasingly I am being called before legislators, stakeholders, and advocacy groups to explain the importance of offering retirement benefits and how those benefits work. In the last year alone we had the highest number ever of retirement related bills that could affect our members. We research those bills, make sure our lawmakers have a sound understanding of the obvious and hidden impacts of retirement plans, and advocate for continuing to provide the best possible plans for our members.

I want to thank all of you for the daily support you provide me. I also thank Benefit Plan Design staff for extracting information and working closely with me to help educate those who influence the future of our retirement benefits.

The month of February is Black History Month. It's a month where all Americans appreciate the African American remembrance of its important people and the events in history.

During my short life span, I had the opportunity to meet many famous sports celebrities (Reggie Jackson and Earvin "Magic" Johnson), political leaders (Rev. Jesse Jackson and Senator Hillary Clinton), and movie stars (Cuba Gooding Jr. and Wesley Snipes) who have really shaped and enlightened my life.

However, there is one person I will never forget. She came to my aide when I needed help during my darkest hour. I will never forget Mrs. Dorothy Miller.

Mrs. Miller was an elderly, widowed Caucasian woman. I met her many years ago while attending Wiley College (Wiley is located in East Texas near the Louisiana state border). Mrs. Miller was the wife and daughter of a former Ku Klux Klansmen.

I met Mrs. Miller while working part-time at the Marshall News Messenger as a photographer and reporter. On an August night, I was traveling back to campus after watching a high school football game when my automobile had a flat tire. I didn't have a spare to replace my flat so I flagged down a car for help. It was Mrs. Miller who kindly helped me contact a local garage to tow my car for repairs.

Mrs. Miller then drove me toward campus. Before we could reach the college, we were stopped by law officers. Apparently, they were looking for a large black male who had beaten and raped several Caucasian women in the vicinity that evening.

I fit the description and was pulled forcibly out of the automobile. By the time I reached the jail, I was beaten unconscious.

I awoke inside a jail cell with nothing on, lying on a filthy mattress. I could barely see, because my eyes were swollen almost completely shut. My ribs were sore and I had trouble breathing. I couldn't speak. I was tasting and choking on my own blood.

I was in serious trouble. I feared the worst was yet to come. I had lost hope.

Mrs. Miller appeared at the jail. She explained to my jailers that I wasn't the suspect they were looking for. She supported my alibi, confirming that I was at the football game earlier. Mrs. Miller was also at the game and she saw me taking pictures and sitting in the press box.

I was released. I went to the hospital for treatment. Mrs. Miller contacted my professors and employer about my absence, but never told them why I was not available.

I never saw Mrs. Miller again after that horrible evening.

I had heard she passed away six years ago. Before her death, she sent me a letter in 1995, apologizing for the way the officers had treated me. She wrote that the color of my skin would lead me to successes and failures in my life. Mrs. Miller further stated in the letter that she had a dream about me and that one day I would have a title attached to my name with the letters EUC.

I have never told anyone this story before. I truly feared for my life. I thought I was going to die. Mrs. Miller came to my aide and I will never forget what was done for me.

It is very important that you have your employee ID on you at all times to ensure security and safety for those working in this building. The IDs are required for entrance into the building, either by the security guard, or by scanning your ID over the Proximity Card Readers. They are also required for entrance into the interior doors before 6:00 a.m. and after 6:00 p.m.

### Retiree survey coming soon

Four hundred randomly selected retirees from all four retirement system will receive the annual retiree survey in the next two weeks. The survey is used to obtain general input from our retiree's on how well ORS is serving their needs and is scheduled to conclude mid-March.

### Cobra Premium Insurance Due coupons issued

Just under 400 Cobra Premium Insurance Due (COBRA pays-us) letters were mailed Tuesday, February 12. The letters told the COBRA participants the annual and monthly amounts due. Monthly coupons accompanied the letters.

### Annual Disability Certification mailed

Approximately 4,500 Annual Disability Certifications for public school and state employee's retirement systems were mailed on Friday, February 8. Each year certification letters are sent to retirees to determine if their pension amount needs to be reduced based on earnings received the previous calendar year. It also certifies that the recipient remains disabled and ensures that ORS knows whether they are on Medicare which could reduce their insurance premium.

A similar mailing will be sent to state police in the next few weeks.

### PA 110 & 111 presentation online

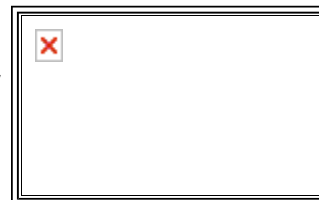

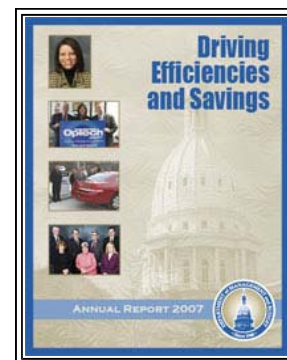
