COMMITTEE REPORTS

Allegation Review Report

Rohwer reported that 27 allegations have been received since the last Board meeting. Twenty-two have been reviewed and five (5) are pending. Of the 22 that have been reviewed, 11 were authorized, 10 were closed and one (1) was returned for additional records.

Rohwer informed that as of July 1, 2014, all allegations must be reviewed by the Chairperson and two (2) additional Board members. The members on the Allegation Review Committee are Rohwer, Kim, and Happel.

NEW BUSINESS

Veterinary Technician Exam Committee – Administrative Rules

Rohwer noted that the Veterinary Technician Exam was reviewed and given in June. The statistics were provided at the March 27, 2014 Board meeting. The recommendation of the Veterinary Technician Exam Committee is that the administrative rules should be amended to remove requirement for applicants to take the State Veterinary Technician Exam, and instead, require applicants to take the National Veterinary Technician Exam.

Carpenter will begin working with the Administrative Rules Committee over the summer to review all of the administrative rules.

Department Update

Lind shared information about SB 597, a bill that would require training for all licensees in identifying the signs of human trafficking. She noted that the law does not apply to veterinarians and veterinary technicians.

Discussion was held regarding the implications of Public Act 97 of 2014. Among other things, the act requires the Disciplinary Subcommittee to impose a fine of at least \$25,000.00 if a violation of section 16221(a) or 16221(b) results in the death of a patient.

Veterinary Technician Exam Committee

Clark stated that the Michigan Veterinary Technician Examination (VTE) was held on Friday, June 20, 2014, at Michigan State University, where 250 candidates sat for the exam. The results will be shared at the September 25, 2014 Board meeting.




