INTRODUCTION OF NEW MEMBERS

Ramsey discussed (FAQ) Facts and Questions informing Haas that she would email an updated record for his approval for questions that will be posted on the LARA Website.

NEW BUSINESS

Occupational Administrative Rules Committee-Recommendations to Governor

Mitchell discussed the (ORR) Occupational Licensing Advisory Rules Committee report regarding the recommendation to deregulate licensees for 18 Occupations and 9 Boards. The (ORR) Report recommended Respiratory Therapists should be de-regulated. These are only recommendations at this time, pending introduction of legislation that would need to be passed through the Legislature and signed by the Governor in order for such legislation to become enacted.

Chairperson's Report

Haas distributed copies of letters from the MSRC and NBRC that were sent to the Governor's office, supporting the need for licensure of Respiratory Care. Haas explained the voluntary nature of the (NBRC) National Board for Respiratory Care and described why the NBRC did not feel it appropriate for its processes to be used in lieu of licensure for any state.

Department Update

The department reported that there were 4,991 licenses.

PUBLIC COMMENT

Teena Culhane and Jeremey Bainbridge, of (MSRC) Michigan Society for Respiratory Care, expressed their concerns about the (ORR) Occupational Licensing Advisory Rules Committee report and the deregulation of the Respiratory Therapists licenses. They spoke of the MSRC role, and of submitting a letter to the Governor's office in support of non-deregulation of Respiratory Therapists.

Derek Schultz commented that he will also be writing a letter in support of non-deregulation of Respiratory Therapy to the Governor.






