BOBCAT SURVEY - 1991-92 ^[1]

Introduction

In order to allow export of bobcat (*Felis rufus*) pelts under the Convention on International Trade in Endangered Species (CITES) the Fish and Wildlife Service compiles data on the harvest and status of bobcats. This documentation is necessary to verify the stability of populations and to allow continued harvest and exportation of pelts. This is the twelfth consecutive year of the bobcat survey in Michigan (Cooley et al. 1981, 1982, 1983, 1984, 1985, 1986, 1987, 1988, 1989, 1990, 1991).

During the winter of 1991-92, the Wildlife Division required that trappers and hunters submit bobcat skulls to the Department of Natural Resources for examination. This allowed Division personnel to age and sex the harvested bobcats by canine tooth examination. This information is summarized for bobcats harvested in the 2 northern Regions (Appendices I and II).

Materials and Methods

A lower canine was extracted after the skull was boiled in water for 1 hour. Measuring the maximum root width and thickness of the canine allowed for sex determination (Friedrich et al. 1983) and age was estimated by cementum layer counts (Crowe 1975).

Results and Discussion

Region I

The number of samples collected (66 in 1991-92, 32 in 1990-91) was much greater this year than last, even though the total harvest was nearly the same (164 in 1991-92, 157 in 1990-91). The sex ratio of bobcats examined from Region I (Table 1) was 144:100 (39:27) males to females. This was the ninth time in 12

years of data collection that the ratio favored males (Cooley et al. 1981, 1982, 1983, 1986, 1987, 1988, 1989, and 1990). The percentage of young-of-the-year (28.8%) was nearly the same as last year (28.1%) but below the average (36%) of all the years bobcats have been examined. The age classes 0-3 years made up 83% of the total animals submitted, being consistent with previous data. The 1-2 year old (34.8%) and the 0-1 year old (28.8%) age classes occurred most frequently in the sample.

Region II

The number of samples collected from Region II increased dramatically (131 in 1991-92, 62 in 1990-91), even though the total harvest was nearly the same (195 in 1991-92, 181 in 1990-91) as last year. The sex ratio of Region II bobcats (Table 2) was 173:100 (83:48) males to females. The data was consistent with past years' data in that males were predominant in the samples collected. The percentage of young-of-the-year (25.2%) was up from last year's data (17.7%). The percentage was near the average (26.1%) of all of the years bobcats have been examined. The age classes 0-3 years made up 71.0% of the total animals submitted, up slightly from last year's figures (67.7%). The yearling (27.5%), young-of-the-year (25.2%), and 2-3 year (18.3%) age classes occurred most frequently in the sample.

Regions I and II

Bobcat harvest regulations for the 1991-92 season included a bag limit of one (unchanged from the previous year) and mandatory submission of the animal's head to the DNR for examination (compared to voluntary submission previously). The harvest increased from 338 in 1990-91 to 359 in 1991-92. The number of samples submitted was up markedly from 94 in 1990-91 to 197 in 1991-92 (a 55% compliance). The combined totals of the submitted skulls from both regions (Table 3) exhibited a distribution in the age classes and sex ratios consistent with past years' data.

Sex ratios calculated by tooth measurement in a previous study did not differ significantly from sex ratios determined by physical examination (Friedrich et al. 1983 and Unpublished Data). However, the differences suggest that the calculated values could be adjusted by +4.4% for juvenile males, -4.5% for juvenile females, -1.5% for adult males, and +1.7% for adult females.

Management Application

The collection and examination of bobcat teeth provided additional baseline information. Using dental measurements for sex determination has allowed for easier data collection. These data, in conjunction with future information will allow the Wildlife Division to develop a population model and help assure Michigan trappers and hunters the opportunity to harvest and export this furbearing species in the future.
