MAPS UPDATE

Wissel, Manager of the Bureau's Pharmacy Division, introduced himself and directed the Board members to a handout on prescription statistics. He provided a brief overview of the Prescription Monitoring Program as well as new Federal Government regulations. Wissel suggested that the Board incorporate using MAPS as a requirement to the minimum standard guidelines. Discussion amongst the Board members was held. Shade appointed Burney and Dull to participate in a multi-board revision of the Controlled Substances Guidelines.
